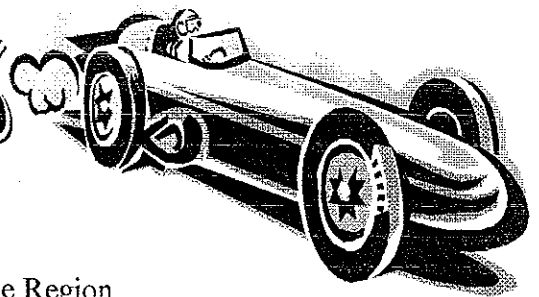

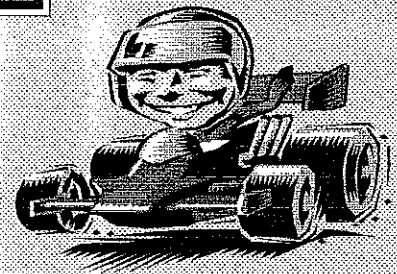
Christmas Party

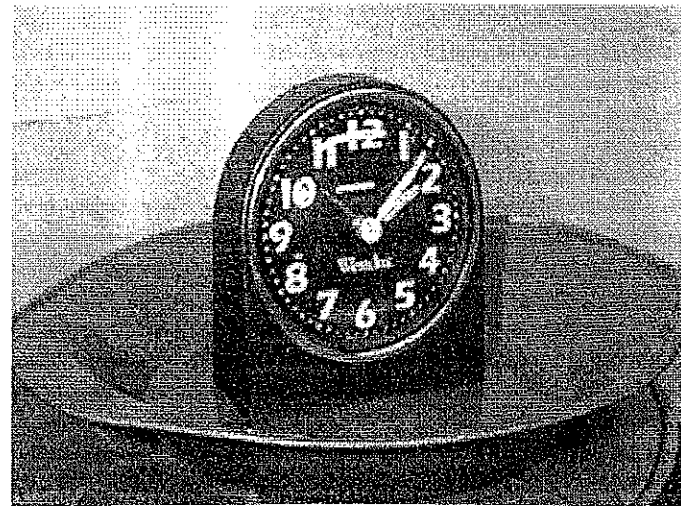

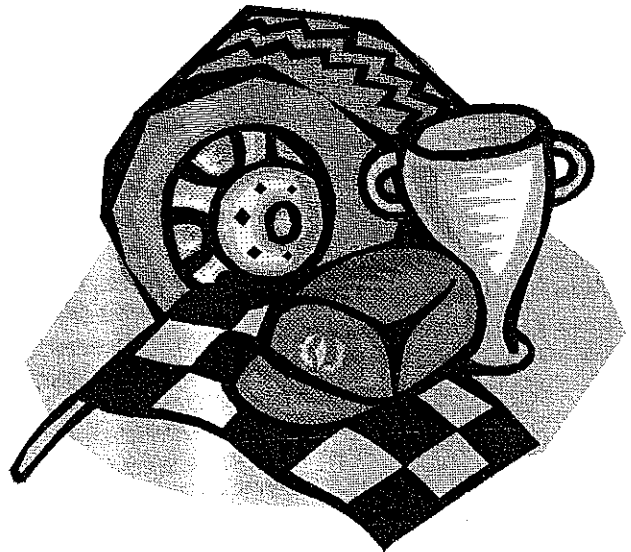

Former Member Injured

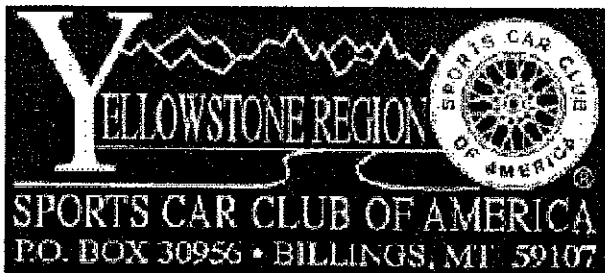
