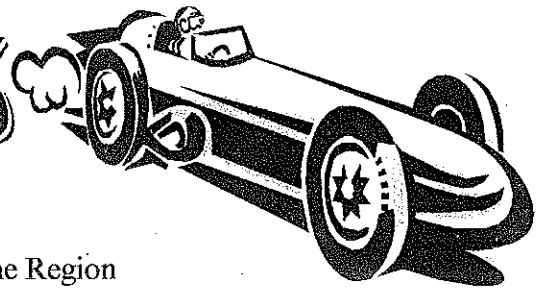

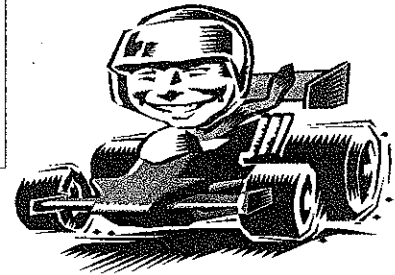
Meeting Minutes
